

Speaker Code of Behaviour and Declaration

All Speakers must:

- be knowledgeable speakers must have and in-depth and broad knowledge of the subject. They must be able to provide examples for attendees to illustrate points/views/methods.
- have experience there is nothing better than lived experience, which in turn enables confident answers to attendee questions.
- inspire and engage we want all the workshops to invigorate, inspire and energise the attendees. Attendees want to take part in the workshop, not just stare at a screen listening to a presenter read from their slides.
- not sell products or services A good workshop will demonstrate problem, action and result and attendees should have some great tips or actions they can 'takeaway'.
- behave in a courteous and respectful manner towards others at all times. They must maintain a professional demeanour, conduct and refrain from improper language. Behaviour such as harassment, sexual harassment and bullying, will not be tolerated.

We ask that Speakers:

- use our PowerPoint template which includes our logo. Slides should be easily legible and professional in appearance.
- rehearse their presentation and ensure it can be completed within the timeframe. Ensure you have the right camera, lighting and audio equipment for a professional look on screen.
- dress in casual business attire.
- are not political. We ask that you refrain from biased political views, please ensure a balanced representation of perspectives to reflect our community's diversity.
- give as much notice as possible if you are no longer able to present your workshop.

Presentation and Recording

We will ask for your permission to share recording/slides before making the workshop recording and presentation available through the members area of our website.

We are looking for speakers from all walks of life and are particularly committed to increase the diversity of our speakers including those from different ethnicities, disabilities and identities.

Shortlisting and final selection

The Hospice Income Generation Network is committed to being open and transparent in all that we do. The selection process for speakers at this virtual conference will be judged on content, budget and equality and diversity.

 - Takeaway practical ideas for attendees to implement
- Budget
 - We have an overall set budget to spend on speakers. The total cost of all speakers will be a factor in our decision-making process.
- Equality and Diversity
 - All applications are anonymised prior to shortlisting, thus making the content the first priority.
